This Addendum is being issued for clarification purposes only. Any bidder that does not acknowledge reading of this Addendum in their formal bid submission will still be considered responsive.

In the previous two Addenda that have been issued for this project, the *Form of Bid*, under Part V of the IFB, was revised, but a new revised *Form of Bid* was not included as an attachment to the Addenda. A revised *Form of Bid* was not included because it is considered permissible to strike the deleted, and portions of deleted line items, and to write in the additional per square foot cost, for soffits, fascia and frieze boards, under the Unit Pricing section in your bid. However, for clarification purposes, a new *Form of Bid*, reflecting the revisions made through the previous two Addenda is included as an attachment (Item No. 1) to this Addendum. Any bidder who does not use this *Form of Bid* will still be considered responsive.

ITEM NO. 1

The revised *Form of Bid* is attached. *Any bidder who does not use this Form of Bid will still be considered responsive.*

ITEM NO. 2

For clarification purposes, HAS is addressing some additional questions that were received after the close of the question and answer period on February 23, 2010.

1. Q: We would like to send a representative down to measure the roof areas for Pickens Patterson Terrace and the Single Family Homes. Could he come down this afternoon around 1:00?

A: No.

2. Q: In looking through the bid package for the 2 roofing jobs, I have discovered that the Bidder's Quality Assurance Form in the packet is not correct. This form applies to a landscaping project. How do you want us to handle this? Secondly I sent a list of questions last week. Are you going to answer them before the bid?
